ALL that piece, parcel and/or lot of land with all improvements thereon situate, lying and being in Greenville County, South Carolina, as being on the Northwestern side of County Cork Drive as shown on lot #74 on a plat of a revision to Lots 62 through 68 of Shamrock Acres as recorded in the RMC Office for Greenville County, South Carolina, in Plat Book RR at Page 133 and according to a later plat entitled "Property of Arthelia Warner" prepared by R.
