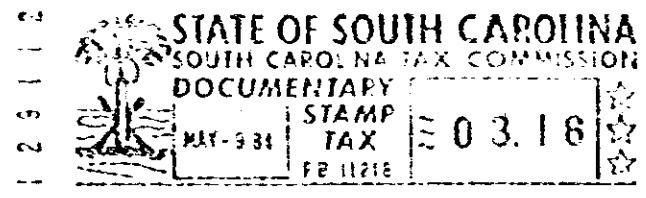

Whereas, I the said David Ray Burton, Sr.

in and by my certain promissory

note in writing, of even date with

these presents, am well and truly indebted to Southern Bank and Trust
Company of Williamston, South Carolina

in the full and just sum of Seven Thousand Eight Hundred Forty-Seven and 81/100
(\$7,847.81) Dollars to be paid in Sixty (60) equal installments in the sum
of One Hundred Ninety-One and 26/100 (\$191.26) Dollars each, beginning
June 8, 1984, and a like installment being due and payable on the
8th day of each and every calendar month thereafter until paid in
full.

with interest thereon from date

at the rate of 16.00 per cent, ~~per annum~~ to be computed and paid monthly

until paid in full; all interest not paid when due to bear interest at the
same rate as principal; and if any portion of principal or interest be at any time past due and un-
paid, then the whole amount evidenced by said note to become immediately due, at the option of
the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing

for an attorney's fee of a reasonable amount besides
all costs and expense of collection, to be added to the amount due on the said note and to be col-

granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto
the said Southern Bank and Trust Company of Williamston, South Carolina,
its Successors and Assigns forever:

All that certain piece, parcel or lot of land with improvements
thereon, lying and situate in the Piedmont Manufacturing Company
Village, in or near the Town of Piedmont, Greenville County, South
Carolina, and being more particularly described as Lot No. 65 section
4, as shown on a plat entitled (Property of Piedmont Manufacturing
Company, Greenville County) made by Dalton & Neves, February, 1950,
Sections 3 and 4 of said plat are recorded in Plat Book Y at Pages
2-5, inclusive and Pages 6-9, inclusive, respectively. According
to said plat, the within lot is known as 14 Liberty Street, and
fronts eighty-nine (89) feet thereon.
