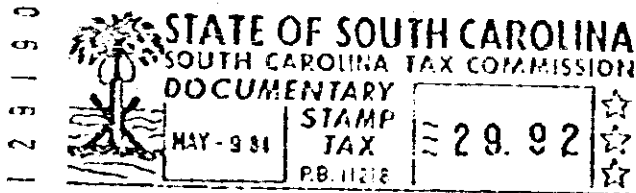

ALL that certain piece, parcel, or lot of land, together with all improvements and all future improvements hereinafter constructed, situate, lying, and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 64 on plat of Devenger Pointe Subdivision, Section One, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 9-F at page 59, reference to which plat is hereby made for a more complete metes and bounds description hereof.

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
