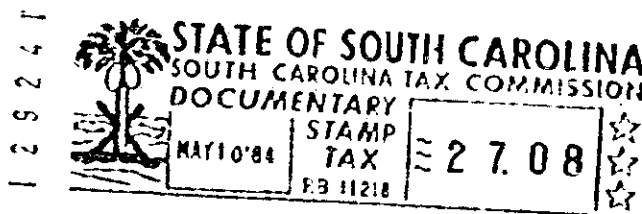

lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has
