THIS MORTGAGE made this 23rd day of MAY, 19 84,

by EDGEWOOD MEDICAL PLAZA, A PARTNERSHIP (a General Partnership formed under the Laws of the State of South Carolina),

(hereinafter referred to as "Mortgagor") and given to SOUTHERN BANK & TRUST CO.

(hereinafter referred to as "Mortgagee"), whose address is Post Office Box 1329, Greenville, S. C. 29602

WITNESSETH:

THAT WHEREAS, Edgewood Medical Plaza, A Partnership is indebted to Mortgagee in the maximum principal sum of Two Hundred Seventy-five Thousand Dollars (\$ 275,000.00 ), Which indebtedness is evidenced by the Note of Edgewood Medical Plaza, A Partnership of even date herewith, said principal (plus interest thereon) being payable as provided for in said Note, (the final maturity of Nov. 15, 1989, which is Five & One-half (5 1/2) years after the date hereof) the terms of said Note and any agreement modifying it are incorporated herein by reference.

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS that the said Mortgagor, for and in consideration of the aforesaid indebtedness and in order to secure the payment thereof together with any renewals or extensions or modifications thereof upon the same or different terms or at the same or different rate of interest and also to secure in accordance with Section 29-3-50, as amended, Code of Laws of South Carolina (1976): (i) all future advances and readvances that may subsequently be made to Mortgagor by Mortgagee evidenced by the aforesaid Note, or by other promissory notes, and all renewals and extensions thereof; and (ii) all other indebtedness of Mortgagor to Mortgagee, now or hereafter existing, whether direct or indirect, the maximum amount of all indebtedness outstanding at any one time secured hereby not to exceed \$ 275,000.00, plus interest thereon, all charges and expenses of collection incurred by Mortgagee including court costs and reasonable attorney's fees, has granted, bargained, sold, released and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described property:

All of that piece, parcel or lot of land, lying, being and situate on the Southern side of Mills Avenue at the intersection of Mills Avenue and Edgewood Drive in the City of Greenville, South Carolina, containing 21,326.35 square feet, more or less, and having according to a plat entitled "Edgewood Medical Plaza - Phase I", prepared by Freeland & Associates, dated November 9, 1983, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 10-E at Page 79, the following metes and bounds:

BEGINNING at an iron pin at the intersection of Mills Avenue and Edgewood Drive and running thence with Mills Avenue N. 39-20 E. 138.00 feet, thence turning and running with the line of the Common Area as shown on said Plat S. 52-41 E. 95.00 feet to a point, thence S. 39-20 W. 7.00 feet to a point, thence S. 40-52 E. 58.15 feet to an iron pin, thence along the line of an alley S. 46-47 W. 150.20 feet to an iron pin on the northern side of Edgewood Drive and thence with Edgewood Drive N. 40-13 W. 135.00 feet to an iron pin, the point of beginning.

ALSO, all of that piece, parcel or lot of land, lying, being and situate on the southern side of Mills Avenue near the intersection of Mills Avenue and Edgewood Drive in the City of Greenville, South Carolina, containing 3,338.23 square feet, more or less, and having according to a plat entitled "Edgewood Medical Plaza-Common Area," prepared by Freeland & Associates, dated November 10, 1983, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 10-F at Page 12, the following metes and bounds:

BEGINNING at a point on the Southern side of Mills Avenue, being approximately 137.7 feet from the intersection of Edgewood Drive and Mills Avenue, and running thence along the Southern side of Mills Avenue N. 39-20 E. 24.00 feet to a point, thence turning and running along the common line of Phase II S. 52-41 E. 103.00 feet to a point, thence S. 10-48 E. 64.24 feet to an iron pin in the line of an alley, thence turning and running along the common line of Phase I N. 40-52 W. 58.15 feet to a point, thence N. 39-20 E. 7.00 feet to a point, thence N. 52-41 W. 95.00 feet to the point of beginning.

This is a portion of the property conveyed to the Mortgagor herein by deed of J. Ernest Lathem, dated December 7, 1983, and recorded on December 9, 1983, in the R.M.C. Office for Greenville County, South Carolina, in Book 1202 at Page 180.
