NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, the Mortgagee's heirs, successors and assigns:

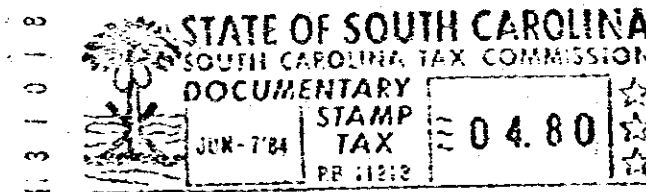
"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Cleveland Township, on the northern side of Geer Highway, containing 1-1/24 acres, more or less, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint corner of property of Fred Kelley and Emma J. Kelley and Effie Dunn and running thence along the line of the property of Effie Dunn N.81-00 E. 104 feet to an iron pin; thence continuing with the line of the property of Effie Dunn, N.20-50 E. 360 feet, 8 inches to an iron pin on the County Road; thence along said County Road, S.65-20 W. 100 feet to an iron pin; thence continuing with said County Road, S.51-30 W. 100 feet to an iron pin; thence continuing with said County Road, S.39-10 W. 75 feet to other property of Fred Kelley and Emma J. Kelley; thence along the line of other property of Kelley, S.04-30 W. 192 feet to the point of beginning.
