Whereas, we the said Robert A. Thompson and Mallie A. Thompson

in and by our certain promissory note in writing, of even date with

these presents, are well and truly indebted to Southern Bank and Trust Company of Williamston, South Carolina

in the full and just sum of Seventeen Thousand Five Hundred Eighty-Three and 76/100 (\$17,583.76) Dollars to be paid in Ninety-Six (96) equal installments in the sum of Three Hundred Sixteen and 07/100 (\$316.07) Dollars each, beginning June 15, 1984 and a like installment being due and payable on the 15th day of each and every calendar month thereafter until paid in full.

with interest thereon from date business prime plus three (3%) percent at the rate of ~~xxxx percent per annum~~ to be computed and paid monthly

Thompson in hand well and truly paid by the said Southern Bank and Trust Company of Williamston, South Carolina at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said Southern Bank and Trust Company of Williamston, South Carolina, its Successors and Assigns forever;
