with interest thereon from date at the rate of 13.00 per centum per annum, to be paid: monthly, as aforesaid

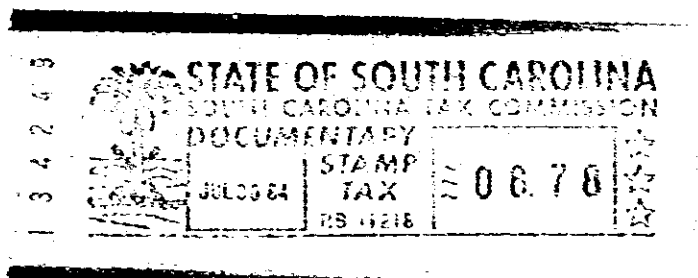

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing 3.43 acres, more or less, according to survey entitled, "Property of Jessie Lee Dill Burgess, Surveyed for J.
