with interest thereon from date at the rate of per note per centum per annum, to be paid per note

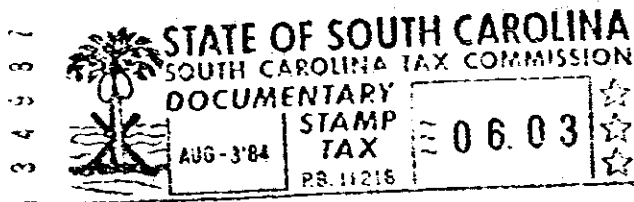

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

ALL that certain piece, parcel or lot of land, with improvements thereon, situate, lying and being in the Town of Simpsonville, County of Greenville, State of South Carolina, being known as Lot 295 on a plat of Powderhorn Subdivision, Map 2, Section IV, recorded in Plat Book 9-F at Page 50 in the R.M.C. Office for Greenville County and more recently shown on a plat prepared for Lee Mathis and Janet Mathis by James R. Freeland, R.L.S., dated July 31, 1984 and recorded in Plat Book 10-V at Page 85; reference being had to the latter plat for a detailed metes and bounds description thereof.

This mortgage is second and junior in lien to that mortgage between Mortgagors and Mortgagee, of even date, recorded herewith.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
