THIS MORTGAGE made this 1st day of August, 1984

by George A. Mullinnix, Jr. and Mary Ellen Mullinnix

(hereinafter referred to as "Mortgagor") and given to SOUTHERN BANK & TRUST CO.

(hereinafter referred to as "Mortgagee"), whose address is P. O. Box 1329, Greenville, South Carolina 29602

WITNESSETH:

THAT WHEREAS, George A. Mullinnix, Jr. and Mary Ellen Mullinnix is indebted to Mortgagee in the maximum principal sum of Two Hundred Fifty Thousand and No/100 Dollars (\$ 250,000.00 ), Which indebtedness is evidenced by the Note of George A. Mullinnix, Jr. and Mary Ellen Mullinnix of even date herewith, said principal (plus interest thereon) being payable as provided for in said Note, (the final maturity of 8/1/94 which is 120 months after the date hereof) the terms of said Note and any agreement modifying it are incorporated herein by reference.

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS that the said Mortgagor, for and in consideration of the aforesaid indebtedness and in order to secure the payment thereof together with any renewals or extensions or modifications thereof upon the same or different terms or at the same or different rate of interest and also to secure in accordance with Section 29-3-50, as amended, Code of Laws of South Carolina (1976): (i) all future advances and readvances that may subsequently be made to Mortgagor by Mortgagee evidenced by the aforesaid Note, or by other promissory notes, and all renewals and extensions thereof, and (ii) all other indebtedness of Mortgagor to Mortgagee, now or hereafter existing, whether direct or indirect, the maximum amount of all indebtedness outstanding at any one time secured hereby not to exceed \$ 250,000.00 plus interest thereon, all charges and expenses of collection incurred by Mortgagee including court costs and reasonable attorney's fees, has granted, bargained, sold, released and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described property:

ALL that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, west of the Town of Greer, on the north side of U. S. Highway 29 (Dual Lane) and on the west side of Buncombe Road and being more particularly described as follows:

BEGINNING at an iron pin at the intersection of the rights of way of U. S. Highway 29 and Buncombe Road and running thence along the right of way of U. S. Highway 29, S.67-36 W. 200 feet to an iron pin; thence N.28-00 W. 100 feet to an iron pin; thence N.67-36 W. 200 feet to an iron pin on the right of way of Buncombe Road; thence along and with the right of way of Buncombe Road, S.38-00 E. 100 feet to the beginning corner.

THIS is the same property as that conveyed to George A. Mullinnix, Jr. by deed of Julian C. Bolt, Jounaud J. Bolt, Roy E. Byars and Jean C. Byars recorded in the RMC Office for Greenville County in Deed Book 1105 at Page 529 on June 27, 1979.
