Belcher aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) the said mortgagors in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Citizens Building and Loan Association, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the East side of Highway No. 14 and the East side of the Old Abandoned Mosteller Road and being shown as lot number FOURTEEN (14) and FIFTEEN (15) on plat of property made for S.J. Mortgage by H.S. Brockman, surveyor, dated Nov. 19, 1941 and recorded in plat book MM page 113, Greenville County R.M.C. Office and having the following courses and distances, to wit: BEGINNING at a stake at the intersection of Highway No. 14 and road leading to Apalache Mill and running thence S. 67-35 E., 300 feet to bend in road; thenceS. 71-55 E., 100 feet to bend in road; thence still with road S. 76-40 E., 200 feet to corner of lot 13; thence as the cornon line of lots 13 and 14, S. 13-20 W., 616.5 feet to center of old abandoned road; thence with said abandoned N. 28-W., 898.4 feet to the beginning corner and containing 4.06 acres, more or less.
