NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, the Mortgagee's heirs, successors and assigns:

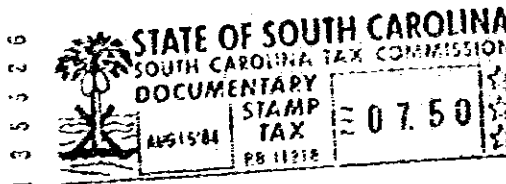
"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, on the north side of the Little Texas Road, containing 2.00 acres, more or less, and having, according to a survey prepared by W. A. Hester, dated March 21, 1946, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the edge of the Little Texas Road at the corner of property now or formerly of Joel Roe and running thence with Roe's line, N. 37 E. 372-1/4 feet to an iron pin; thence N. 88 W. 401 feet to stone in road; thence S. 1 W. 278-1/2 feet to an iron pin on edge of Little Texas Road; thence with Little Texas Road, S. 75 E. 179-1/2 feet to the beginning corner.
