THIS MORTGAGE is made this 29th day of August 1984 between the Mortgagor, George F. and Nancy B. Friedel (herein "Borrower"), and the Mortgagee, AMERICAN FEDERAL BANK, FSB a corporation organized and existing under the laws of THE UNITED STATES OF AMERICA, whose address is 101 EAST WASHINGTON STREET, GREENVILLE, SOUTH CAROLINA (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of ten thousand, sixty seven and 3/100 Dollars, which indebtedness is evidenced by Borrower's note dated August 29, 1984 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on August 20, 1989

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville State of South Carolina:

ALL that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 364 of a subdivision known as Devenger Place Section 15 according to a plat thereof prepared by Dalton & Neves C., Engineers, dated May, 1981 being recorded in the RMC Office for Greenville County in Plat Book 8-P at Page 26 and having, according to said plat, such metes and bounds as are shown thereon.

This being a portion of the same property conveyed to the Grantor by deed of Harry R. Kennedy and Elizabeth B. Kennedy recorded in the RMC Office for Greenville County on May 18, 1981 in Deed Vol. 1148 at Page 222.

This conveyance is make subject to any restrictions, reservations, zoning ordinances or easements that may appear of record, on the recorded plat(s), or on the premises.
