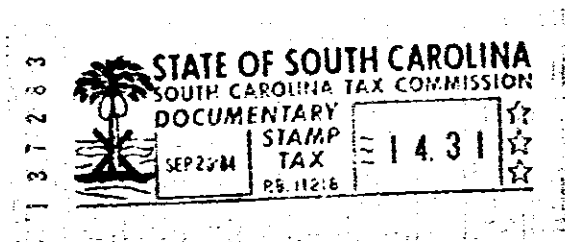

THIS MORTGAGE is made this first day of September
1984, between the Mortgagor, Randy Blackwell
R.M.G. (herein "Borrower"), and the Mortgagee, South Carolina
Federal Savings & Loan Association, a corporation organized and existing under the laws of United States of
America, whose address is 1500 Hampton Street, Columbia, South Carolina, (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Forty Seven Thousand, Six
Hundred Fifty Five and No/100 Dollars, which indebtedness is evidenced by Borrower's note
dated September 1, 1984 (herein "Note"), providing for monthly installments of principal and interest,
