THIS MORTGAGE is made this 19th day of September, 1984, between the Mortgagor, Johnny L. Hunnicutt and Irma M. 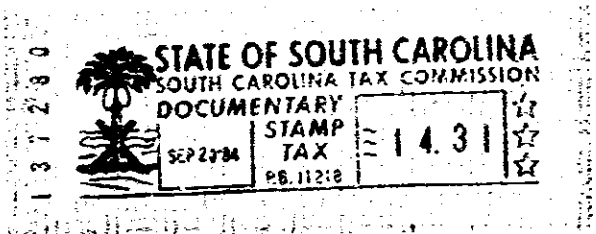
