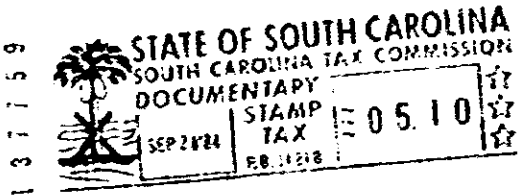

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern side of Decatur Street, near the City of Greenville, being shown as Lot 151 on a plat of Sans Souci Housing, Inc., recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book X at page 61, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Decatur Street at the joint front corner of Lots 150 and 151, and running thence along the line of Lot 150, N. 57-00 W. 150 feet to an iron pin on the south-eastern edge of a 15-foot alley; thence with said alley N. 39-13 E. 54.4 feet to an iron pin; thence along the line of Lot 152, S. 64-45 E. 153.5 feet to an iron pin on the northwestern side of Decatur Street; thence along Decatur Street S. 29-17 W. 73 feet to the beginning corner.
