Words Used In This Document

(A) Mortgage—This document, which is dated ^{Oct 2} ~~September~~ ²⁹ ~~19~~ ¹⁹⁸⁴ will be called the "Mortgage".

(B) Mortgagor—W. Bryan Davidson and Evelyn J. Davidson will sometimes be called "Mortgagor" and sometimes simply "I", "Me", "my", "mine", "myself", and "us" refer to ~~the~~ mortgagor.

(C) Lender—The South Carolina National Bank will be called "Lender" and sometimes simply "you", "Your" and "yours" refer to Lender. Lender is a national banking association which was formed and which exists under the laws of the United States of America.

Lender's address is P. O. Drawer 969, Greenville, SC 29602

(D) Note—The note, note agreement, or loan agreement signed by W. Bryan Davidson and Evelyn J. Davidson and dated September 29, 1984 will be called the "Note". The Note shows that I have promised to pay Lender

which I have promised to pay in full by September 29, 1987

If this box is checked, finance charges or interest under the Note will be deferred, accrued, or capitalized.

(E) Property—The property that is described below in the section entitled "Description Of The Property" will be called the "Property".

My Transfer To You Of Rights In The Property

On this date, because you loaned me the money for which I gave you the Note, I mortgage, grant and convey the Property to you, your successors and assigns, subject to the terms of this Mortgage. This means that by signing this Mortgage, I am giving you those rights that are stated in this Mortgage and also those rights that the law gives to lenders who hold mortgages on real property. I am giving you these rights to protect you from possible losses that might result if I fail to:

(A) Pay all the amounts that I owe you as stated in the Note and any future advances made under Paragraph 17 of this Mortgage.

(B) Pay, with interest or finance charges, any amounts that you spend under this Mortgage to protect the value of the Property and your rights in the Property.

(C) Keep all of my other promises and agreements under the Note and/or this Mortgage.

This Mortgage secures any renewals, extensions, and/or modifications of the Note.

Description Of The Property

(A) The Property which I mortgage, grant, and convey to you, your successors and assigns, is located in Greenville County and has the following legal description:

ALL that certain piece, parcel or lot of land, situate, lying and being in the County of Greenville, State of South Carolina, being shown as Lot No. 70 on a plat of Holly Tree Plantation, Phase III, Section II, prepared by Piedmont Engineers, Architects and Planners, dated April 3, 1979, and recorded in the Office of the R.M.C. for Greenville County in Plat Book 7-C at page 27, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Briarwood Drive at the joint front corner of Lots 70 and 69, and running thence with Lot 69, S. 76-56 W. 149.78 feet to an iron pin at the joint rear corner of Lots 69 and 70; thence N. 13-08 W. 110 feet to an iron pin at the joint rear corner of Lots 70 and 71; thence with Lot 71, N. 76-56 E. 149.85 feet to an iron pin on Briarwood Drive; thence with said drive S. 13-04 E. 110 feet to the point of beginning.

This is the same property conveyed to the mortgagors by deed of Franklin Enterprises, Inc. dated April 15, 1982, and recorded in the R.M.C. Office for Greenville County, South Carolina, on April 16, 1982, in Deed Book 1165 at page 435.

- (C) All rights in other property I have as owner of the property described in paragraph (A) of this section. These rights are known as "easements, rights and appurtenances attached to the property";
- (D) All rents or royalties from the property described in paragraph (A) of this section;
- (E) All mineral, oil and gas rights and profits, water, water rights and water stock that are part of the property described in paragraph (A) of this section;
- (F) All rights that I have in the land which lies in the streets or roads in front of, or next to, the property described in paragraph (A) of this section;
- (G) All fixtures that are now or in the future will be on the property described in paragraphs (A) and (B) of this section, and, to the extent allowed by law, all replacements of and additions to those fixtures;
- (H) All of the rights and property described in paragraphs (B) through (F) of this section that I acquire in the future; and
- (I) All replacements of and/or additions to the property described in paragraphs (B) through (F) and paragraph (H) of this section.

You, your successors and assigns, are to have and to hold the Property, subject to the terms of this Mortgage.
