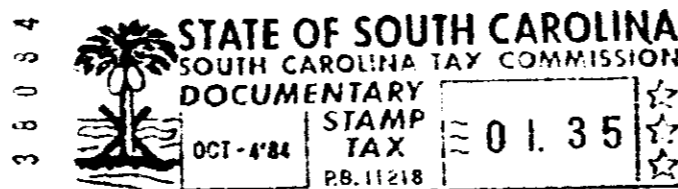
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township being known and designated as the front portion of Lot No. 33 plat of Conestee, by R.E. Dalton dated December 1943, recorded in the RMC Office for Greenville County in Plat Book "K" at page 276 and being fully described as follows to-wit:

BEGINNING at an iron pin on east side of Main Street, said pin being the joint front corner of Lots No, 34 and 33, and running thence along the eastern side of Main Street N 42-16 E 92 feet to a point in the line of Lot No. 34; thence along the line of Lot No. 34 N 48-10 W 33 feet to the point of beginning.
