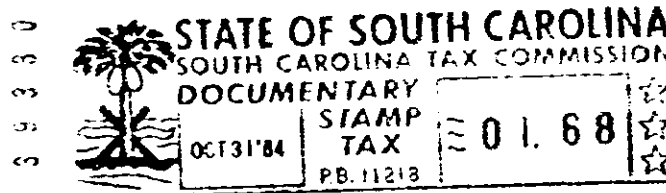
these presents, are well and truly indebted to Southern Bank and Trust
