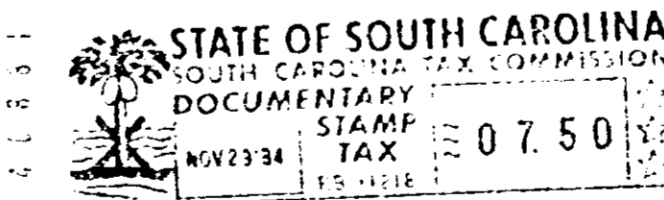
"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE.

ALL that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the southern side of Glensprings Lane, and containing 3.25 acres, more or less, as shown on a plat entitled "Property of W. R. and Elizabeth M. Williams", prepared by W. R. Williams, Jr., dated January, 1974, revision October, 1975 and recorded in the RMC Office for Greenville County in Plat Book 5-J at Page 67 and having such metes and bounds as shown thereon, reference to said plat being made for a more complete description.

THIS is the same property as that conveyed to the Mortgagors herein by deed of W. R. Williams and Elizabeth M. Williams recorded in the RMC Office for Greenville County in Deed Book 1027 at Page 544 on November 25, 1975.

THIS is a second mortgage subject to that certain first mortgage to The Federal Land Bank of Columbia recorded in the RMC Office for Greenville County in Mortgage Book 1378 at Page 389 on September 22, 1976 in the original amount of \$25,000.00.

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
