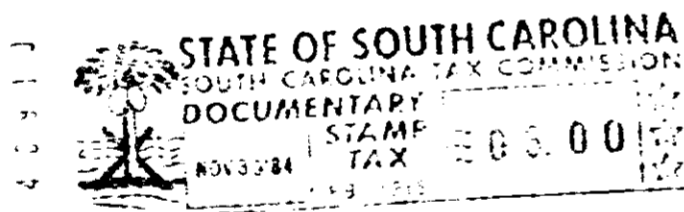

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 15 on a plat entitled Heathwood Subdivision, made by Dalton & Neves, Engineers, July, 1956, recorded in the RMC Office for Greenville County, South Carolina in Plat Book "KK" at Page 35 being on the southern side of East Lee Road and having metes and bounds as shown on said recorded plat.
