Dollars (\$ 8,589.62) due and payable

In monthly installments of One Hundred Ninety-Six and 54/100 Dollars (\$196.54) commencing December 27, 1984 and One Hundred Ninety-Six and 54/100 Dollars (\$196.54) on the 27th day of each and every month thereafter until paid in full.

with interest thereon from December 3, 1984 at the rate of -13.25- per centum per annum, to be paid: Monthly

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

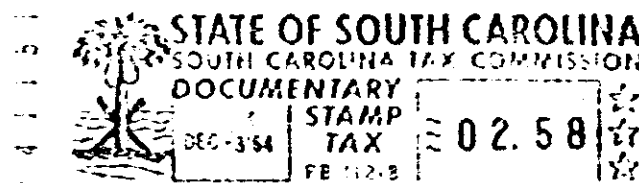
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, on the White Horse Road, being a portion of the Samuel N. Watson property, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the corner of Jack McCall's property and running thence N. 83 W. 417 feet to an iron pin; thence S. 9 E. 209 feet to an iron pin on a branch; thence S. 3 E. crossing said branch, 417 feet to an iron pin in the center of White Horse Road; thence N. 9 W. 209 feet to an iron pin in the center of said road, at the point of beginning.

The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
