THIS MORTGAGE is made this 7th day of December, 19 84  
between the Mortgagor CHESTER E. ODOM and VICKY R. ODOM  
(herein "Borrower"), and the Mortgagee, ALLIANCE MORTGAGE COMPANY,  
a corporation organized and existing under the laws of the State of Florida,  
whose address is Post Office Box 2259,  
Jacksonville, Florida 32232 (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of \$ 34,200.00,  
which indebtedness is evidenced by Borrower's Note dated December 7, 1984 (herein "Note"),  
providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner  
paid, due and payable on January 1, 20 15.

TO SECURE to Lender: (a) the repayment of the indebtedness evidenced by the Note with interest thereon,

hereof (herein "Future Advances") Borrower does hereby mortgage, grant, and convey to Lender and Lender's  
successors and assigns the following described property located in the County of Greenville,  
State of South Carolina:

ALL that certain piece, parcel, or tract of land containing 1.0 acre, more or less,  
situate, lying and being in Paris Mountain Township, Greenville County, South  
Carolina, and having, according to a Plat prepared by Jones Engineering & Land  
Surveying, dated December 5, 1984, recorded in the RMC Office for Greenville County  
in Plat Book 10-D, at Page 23, the following metes and bounds:

BEGINNING at a nail cap in the center of N. Parker Road (formerly New Poor House  
Road and also formerly known as Thompson Road), and running thence with the center  
line of N. Parker Road, S 47-02 W, 167.66 feet to a nail cap; thence N 57-10 W,  
260.00 feet to an iron pin; thence N 47-02 E, 167.66 feet to an iron pin; thence
