"Borrower") agrees that the following provisions of this rider (the "Rider") shall be incorporated into that certain mortgage of even date herewith executed by Borrower, as mortgagor, in favor of South Carolina Federal Savings Bank, ("Note Holder"), as mortgagee, and that certain rider to such mortgage of even date therewith, executed by Borrower, which modifies the mortgage (collectively, the "Mortgage"), to which Mortgage this Rider is attached, as well as that certain Note of even date herewith made by Borrower in favor of Note Holder, which the Mortgage secures.

- 1. Maximum and Minimum Interest Rate

 Nothwithstanding anything to the contrary contained in the Mortgage and Note, the rate at which interest shall accrue under the Note shall not be changed upward or downward by more than 2%

 on any Change Date, and shall not be changed upward or downward by more than 5 1/8%

 or downward by more than 5 1/8%

 over the life of the loan.
- 2. Effectiveness of Provisions

 Except as otherwise provided in this Rider, all of the provisions of the Mortgage and Note shall remain in full force and effect.
