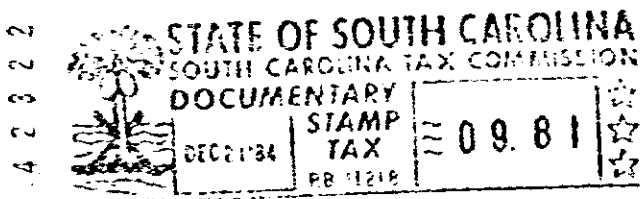

MORTGAGE

THIS MORTGAGE ("Security Instrument") is given on December 19, 1984. The mortgagor is Dan A. Ray, Martha B. Ray, David A. Ray, Regina Ray ("Borrower"). This Security Instrument is given to Alliance Mortgage Company, which is organized and existing under the laws of Florida, and whose address is P. O. Box 4130, Jacksonville, Florida ("Lender"). Borrower owes Lender the principal sum of Thirty Two Thousand Six Hundred Fifty and 00/100 Dollars (U.S. \$32,650.00). This debt is evidenced by Borrower's note dated the same date as this Security Instrument ("Note"), which provides for monthly payments, with the full debt, if not paid earlier, due and payable on January 1, 2015. This Security Instrument secures to Lender: (a) the repayment of the debt evidenced by the Note, with interest, and all renewals, extensions and modifications; (b) the payment of all other sums, with interest, advanced under paragraph 7 to protect the security of this Security Instrument; and (c) the performance of Borrower's covenants and agreements under this Security Instrument and the Note. For this purpose, Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in Greenville County, South Carolina:

ALL that certain piece, parcel or unit with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Unit 12A Ridgeview Horizontal Property Regime, as is more fully described in Master Deed of Ridgeview Horizontal Property Regime dated July 3, 1984 and recorded in the R. M. C. Office for Greenville county on July 23, 1984 in Deed Volume 1217, page 572.

DERIVATION: This is the same property heretofore conveyed to the Mortgagors herein by deed of Clarence F. Evans recorded simultaneously herewith in the R. M. C. Office for Greenville County.

TO HAVE AND TO HOLD such property unto Lender and Lender's successors and assigns, forever, together with all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances, rents, royalties, mineral, oil and gas rights and profits, water rights and stock and all fixtures now or hereafter a part of the property. All replacements and additions shall also be covered by this Security Instrument. All of the foregoing is referred to in this Security Instrument as the "Property."

BORROWER COVENANTS that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property and that the Property is unencumbered, except for encumbrances of record. Borrower warrants and will defend generally the title to the Property against all claims and demands, subject to any encumbrances of record.

THIS SECURITY INSTRUMENT combines uniform covenants for national use and non-uniform covenants with limited variations by jurisdiction to constitute a uniform security instrument covering real property.
