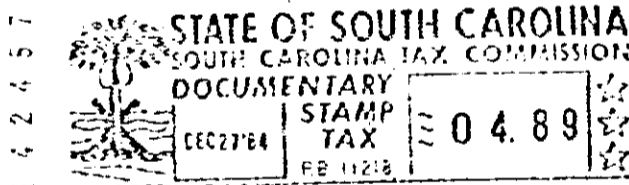

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Travelers Rest, near the northeastern side of West Road, containing 0.56 acres according to a plat of the property of Matthew Bowen, prepared by W. R. Williams, Jr., Engineer/Surveyor #3979, dated March 3, 1978, and recorded in the RMC Office for Greenville County in Plat Book 6-J, at page 97, and having such metes and bounds as shown thereon.
