

EXHIBIT APARCEL NO. 1:

ALL that certain piece, parcel or tract of land in Greenville County, South Carolina containing 7.08 acres, more or less, and being shown on plat of property of Roewood Assoc., dated May 1978, revised August 27, 1979, and February 14, 1980, prepared by W. BEGINNING at a point in line of property of Herman Krieger and Greenville County, said point of beginning being 138.0 feet from the center of proposed frontage road and running thence with the property line of property of Herman Krieger and Greenville County N. 50-50 W. 145.0 feet; thence N. 38-31 E. 35.6 feet; thence S. 50-50 E. 145.0 feet; thence S. 38-31 W. 35.6 feet to the point of beginning.
