MORTGAGE

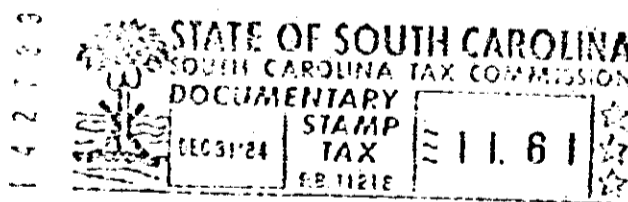
THIS MORTGAGE ("Security Instrument") is given on December 31, 1984
 19..... The mortgagor is LAURA L. LINEBURGER
 ("Borrower"). This Security Instrument is given to
U. S. Shelter Corporation, which is organized and existing
 under the laws of Delaware, and whose address is c/o C&S Real Estate Services,
Inc., P.O. Box 10636, Charleston, S.C. 29411 ("Lender").
 Borrower owes Lender the principal sum of Thirty-eight Thousand, Seven Hundred and
no./100 Dollars (U.S. \$ 38,700.00). This debt is evidenced by Borrower's note

 the Note. For this purpose, Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and
 assigns the following described property located in Greenville County, South Carolina:

All that certain piece, parcel or unit, situate, lying and being in the
 State of South Carolina, County of Greenville, being known and designated as
 Unit No. 32 of Riverbend Horizontal Property Regime, the Master Deed for
 which is recorded in the RMC Office for Greenville County in Deed Book 1174
 at Pages 91 through 165, inclusive, amended by instrument recorded September
 23, 1982 in Book 1176 at Page 390, and by instrument recorded June 2, 1983
 in Deed Book 1189 at Page 489.

Being the same property conveyed to mortgagor herein by deed of U.S.
 Shelter Corporation, dated 12/31/84, and recorded simultaneously herewith
 in Deed Book 1230 at Page 192, office of the R.M.C. for
 Greenville County, South Carolina.

 Borrower warrants and will defend generally the title to the Property against all claims and demands, subject to any
 encumbrances of record.
