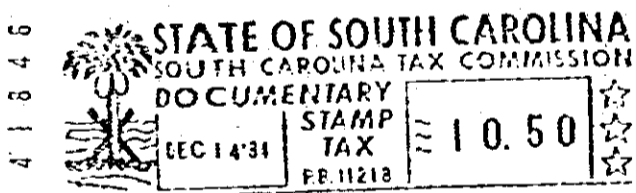

MORTGAGE

THIS MORTGAGE ("Security Instrument") is given on December 13, 1984. The mortgagor is James F. Stephenson and Debra K. Stephenson ("Borrower"). This Security Instrument is given to Alliance Mortgage Company, which is organized and existing under the laws of Florida, and whose address is P.O. Box 4130, Jacksonville, Florida 32231 ("Lender"). Borrower owes Lender the principal sum of Thirty-Five Thousand and No/100 Dollars (U.S. \$35,000.00). This debt is evidenced by Borrower's note dated the same date as this Security Instrument ("Note"), which provides for monthly payments, with the full debt, if not paid earlier, due and payable on January 1, 2015. This Security Instrument secures to Lender: (a) the repayment of the debt evidenced by the Note, with interest, and all renewals, extensions and modifications; (b) the payment of all other sums, with interest, advanced under paragraph 7 to protect the security of this Security Instrument; and (c) the performance of Borrower's covenants and agreements under this Security Instrument and the Note. For this purpose, Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in Greenville County, South Carolina:

ALL that certain piece, parcel or lot of land in the County of Greenville, State of South Carolina, on the northern side of Holgate Court, near the City of Greenville, being shown as Lot No. 27 on plat of Section III, Wade Hampton Gardens, recorded in the RMC Office for Greenville County, S.C., in Plat Book YY at Page 179. Reference is hereby made to said plat for a more complete description.

THIS being the same property conveyed to the mortgagors herein by deed of Jimmy M. Hayes as recorded in the RMC Office for Greenville County, S.C. herewith.

Borrower warrants and will defend generally the title to the Property against all claims and demands, subject to any encumbrances of record.

THIS SECURITY INSTRUMENT combines uniform covenants for national use and non-uniform covenants with limited variations by jurisdiction to constitute a uniform security instrument covering real property.
