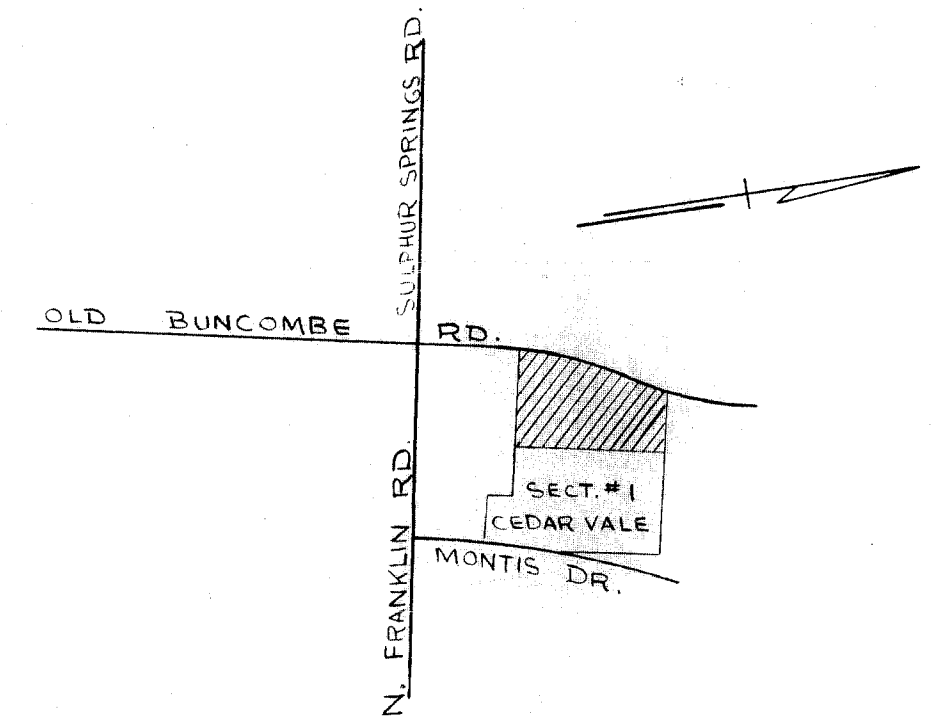

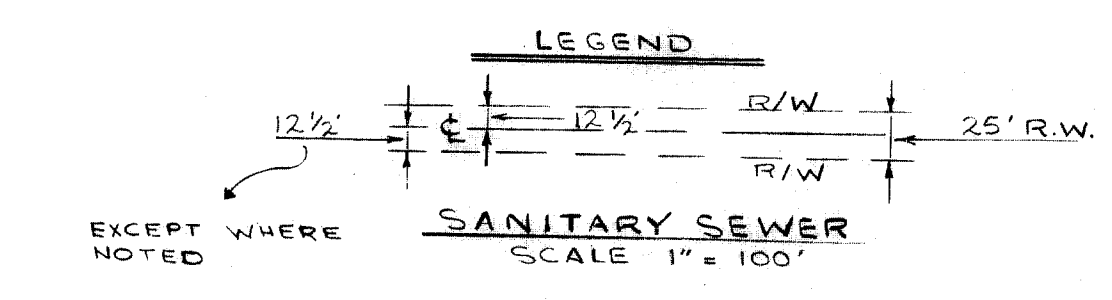
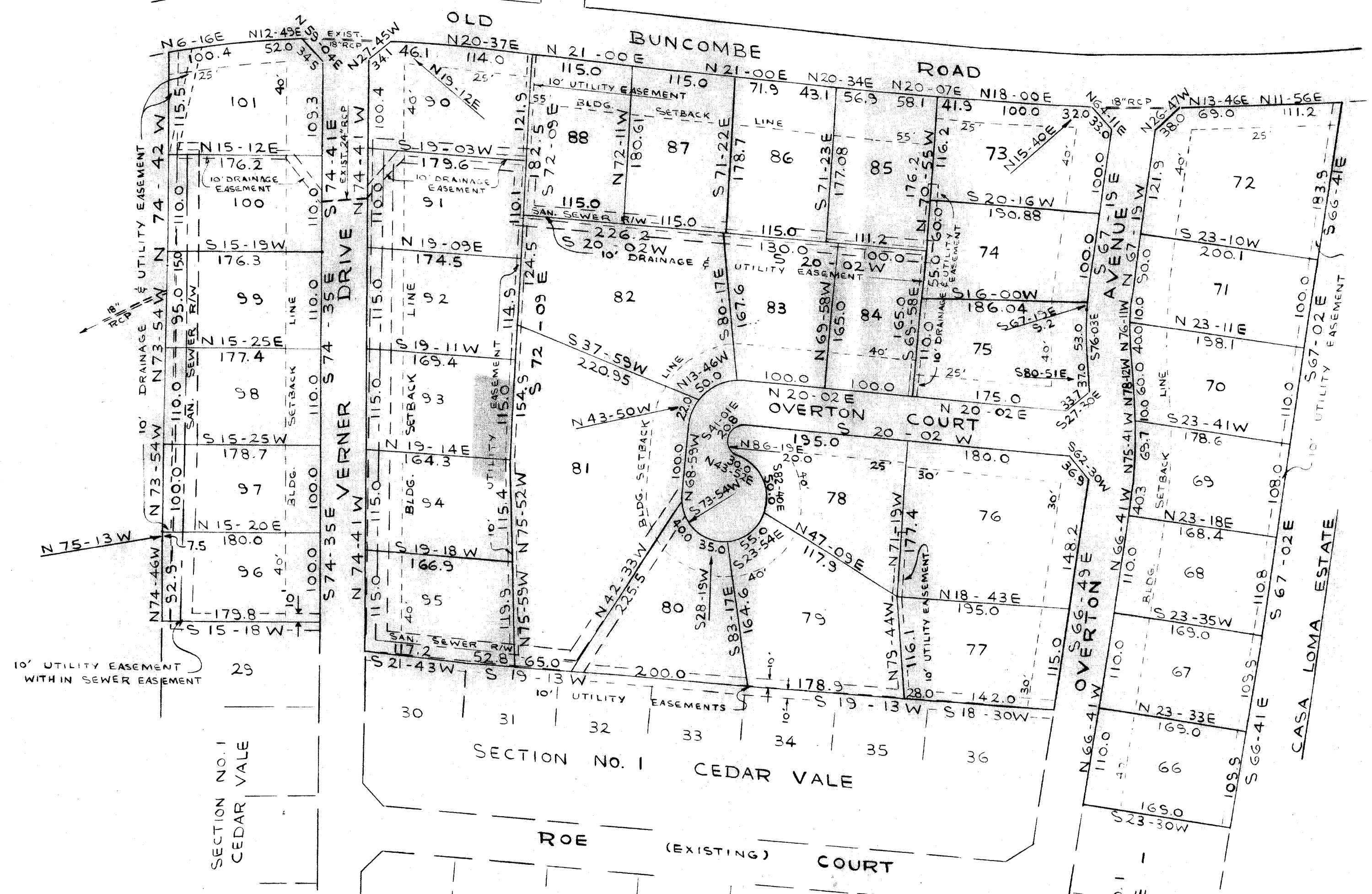
Cedar Vale Section II was signed on December 24, 1969.

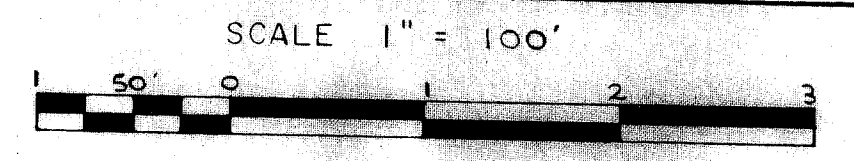
