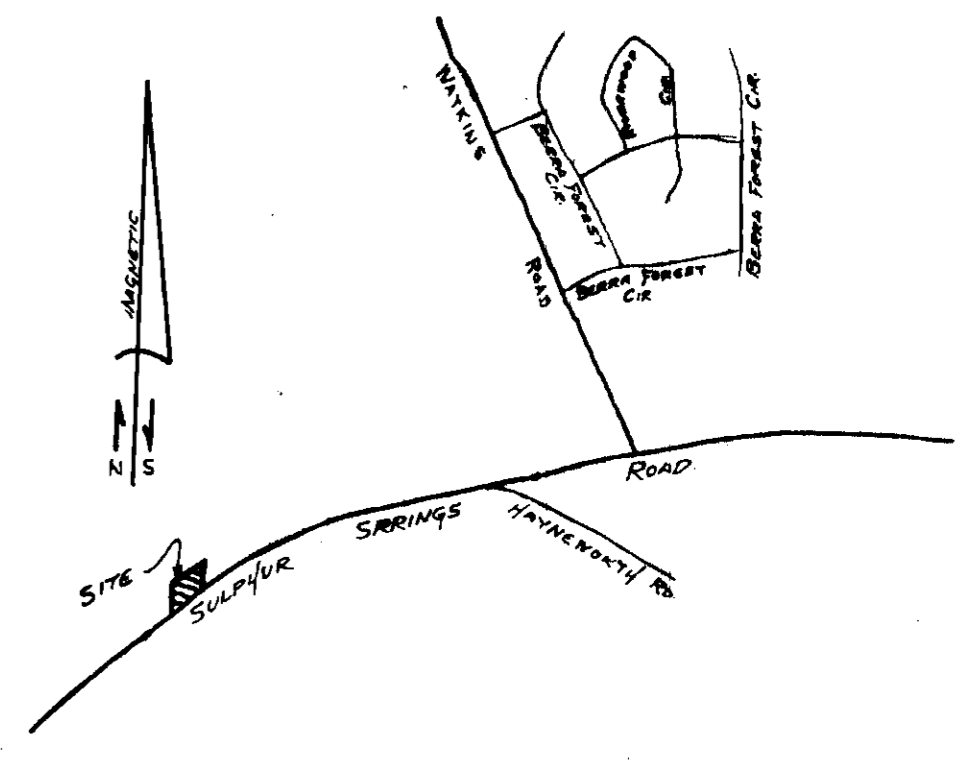


LOCATION MAP

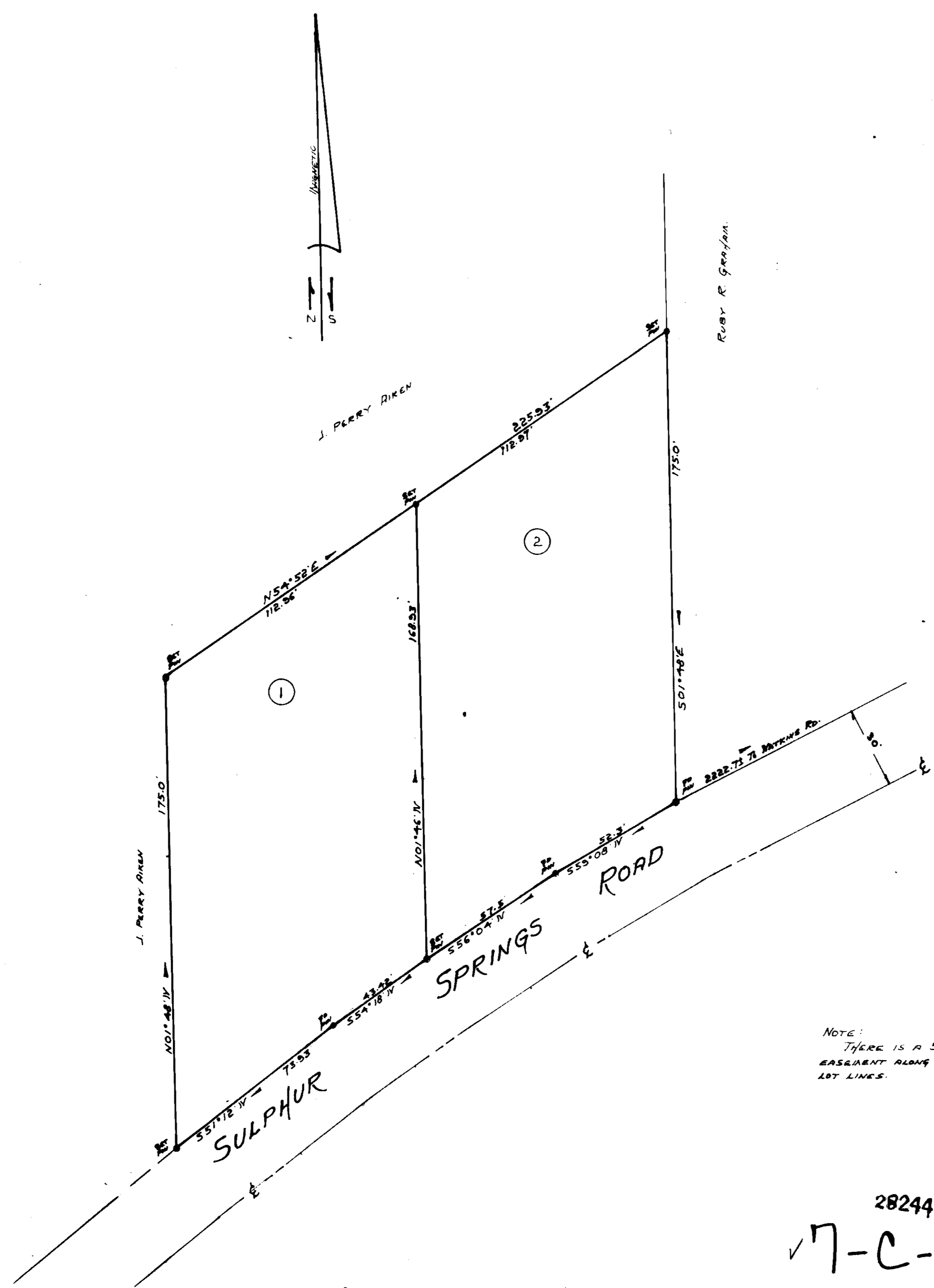
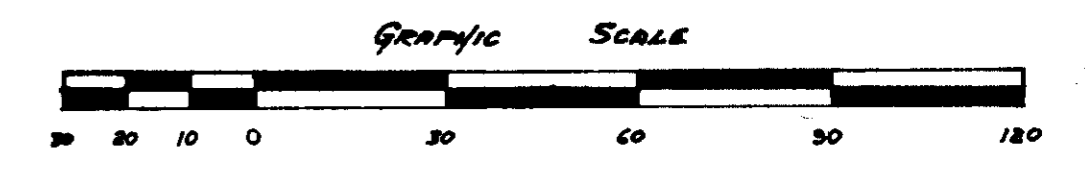
