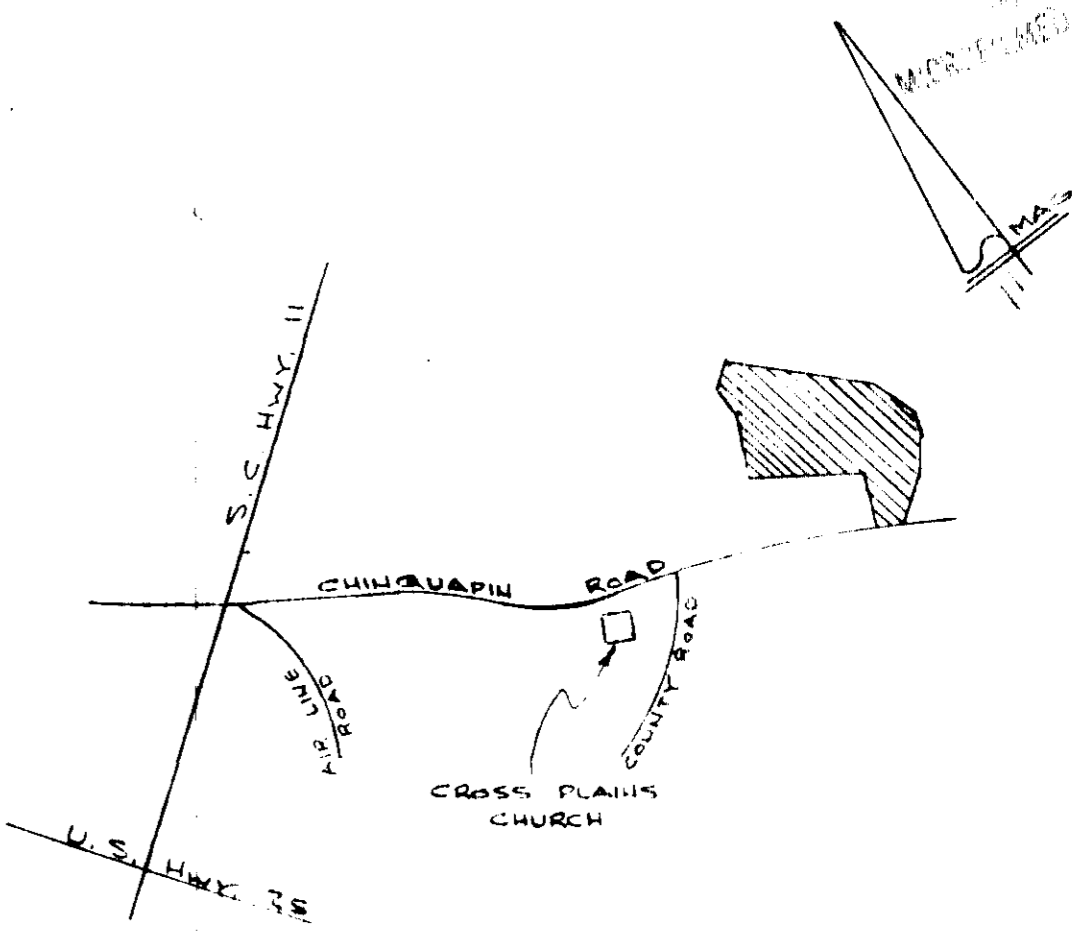
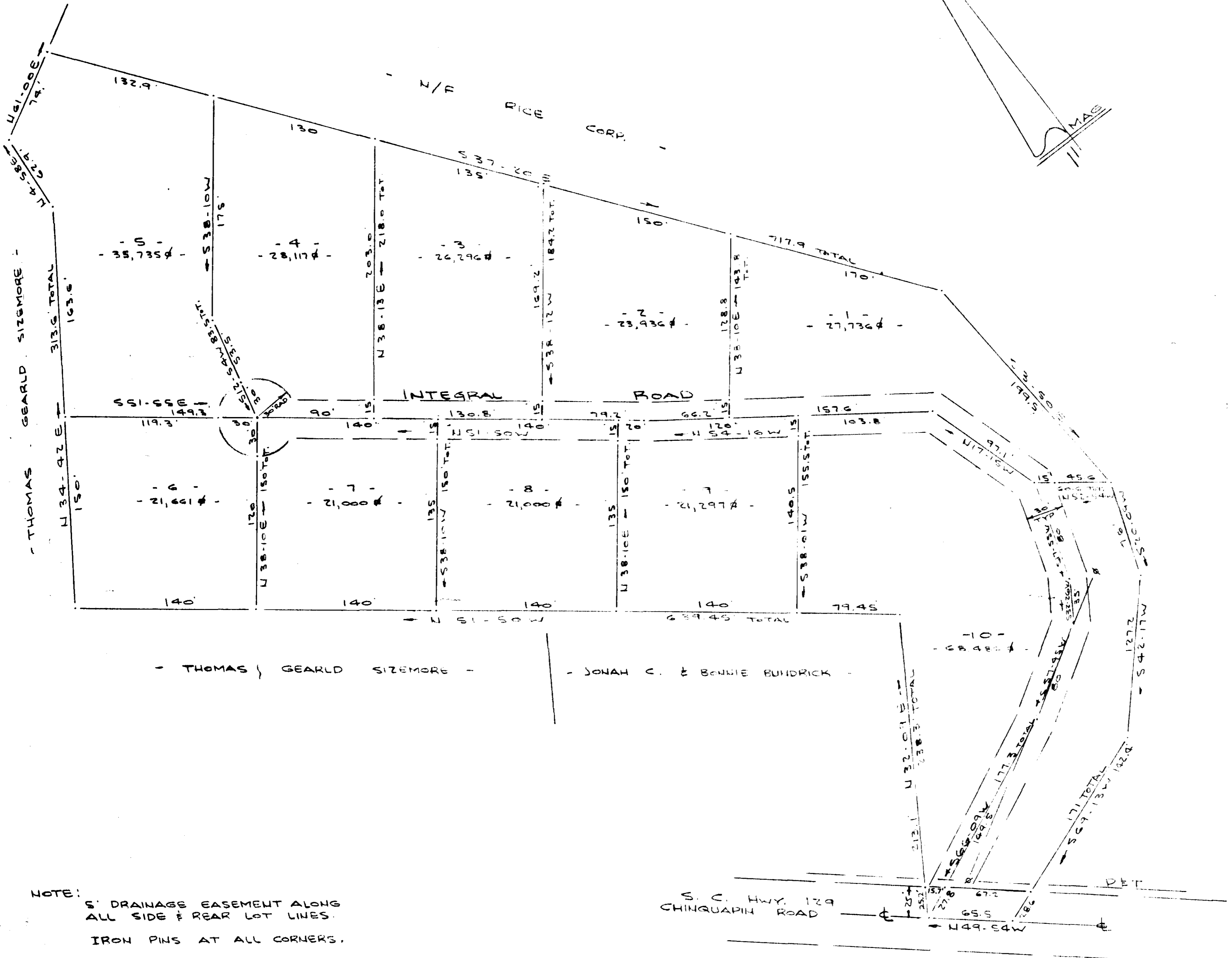

The road shown hereon, known as "Integral Road", is a private road owned in fee simple by the owners of lot 1 through 10, inclusive, as tenants in common. Each owner of a lot shall have an undivided one-tenth (1/10) interest in said road. Also, said road shall be a non-exclusive easement for the benefit of said ten (10) lots for the purpose of ingress and egress to and from said lots, and also for the purpose of installing and maintaining a two and one-half (2 1/2") inch water line which shall be owned by the owners of said ten (10) lots as tenants in common. Said easement shall be permanent, shall be for the mutual benefit of said lots and the owners thereof, their heirs, successors and assigns and shall run with said property. The road is not a public right of way and will not be maintained by the county unless improved to county standards, dedicated to the public and accepted by the county.
