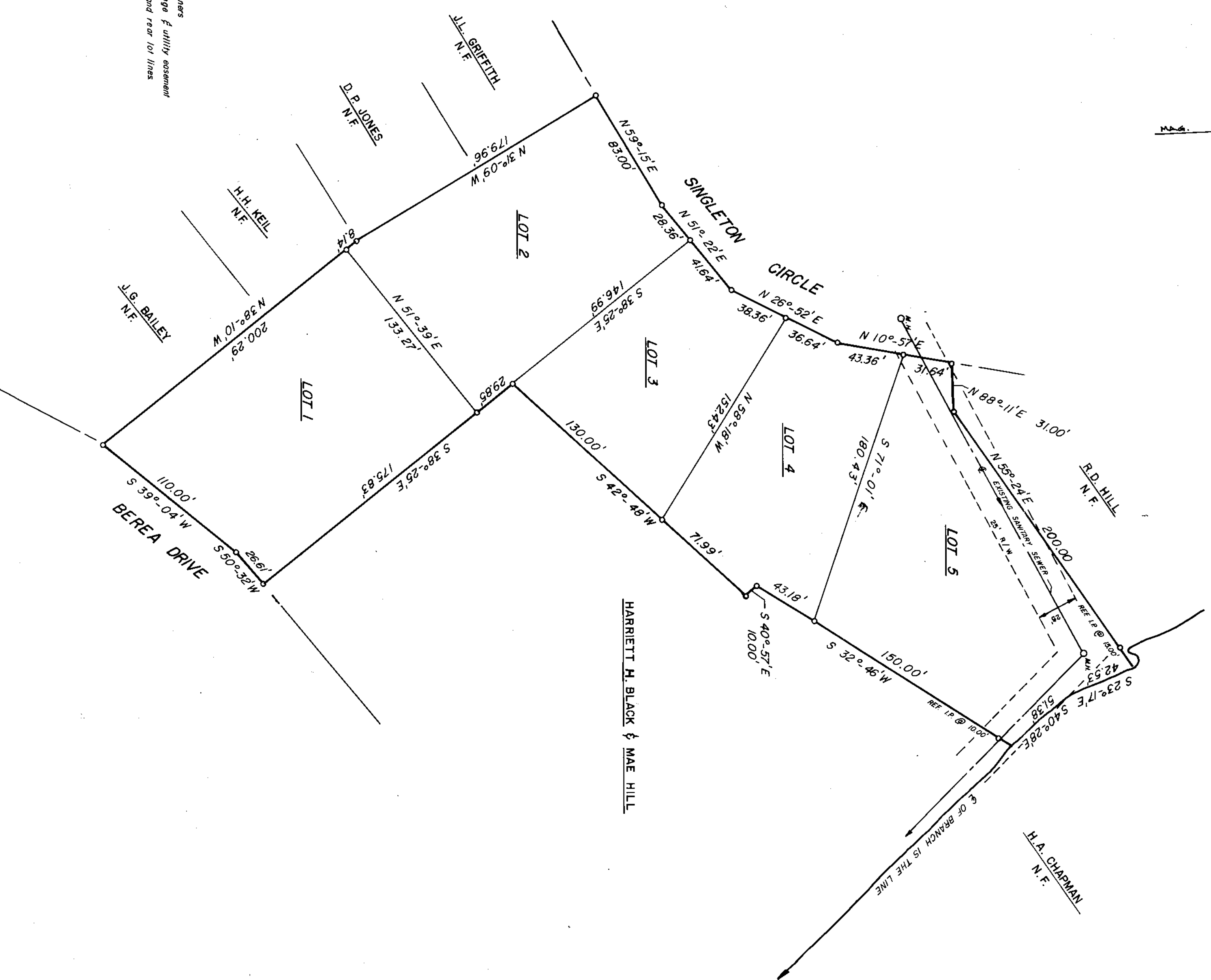
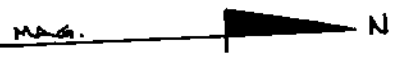

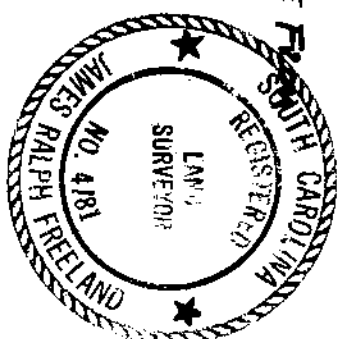

2. There is a 5' drainage each side of all side and rear lot lines

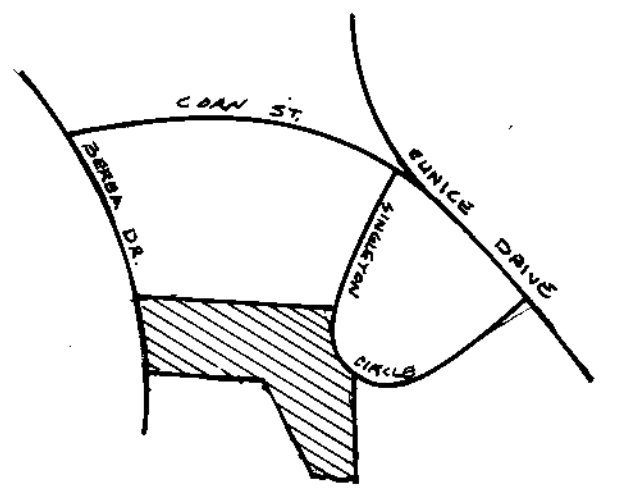
