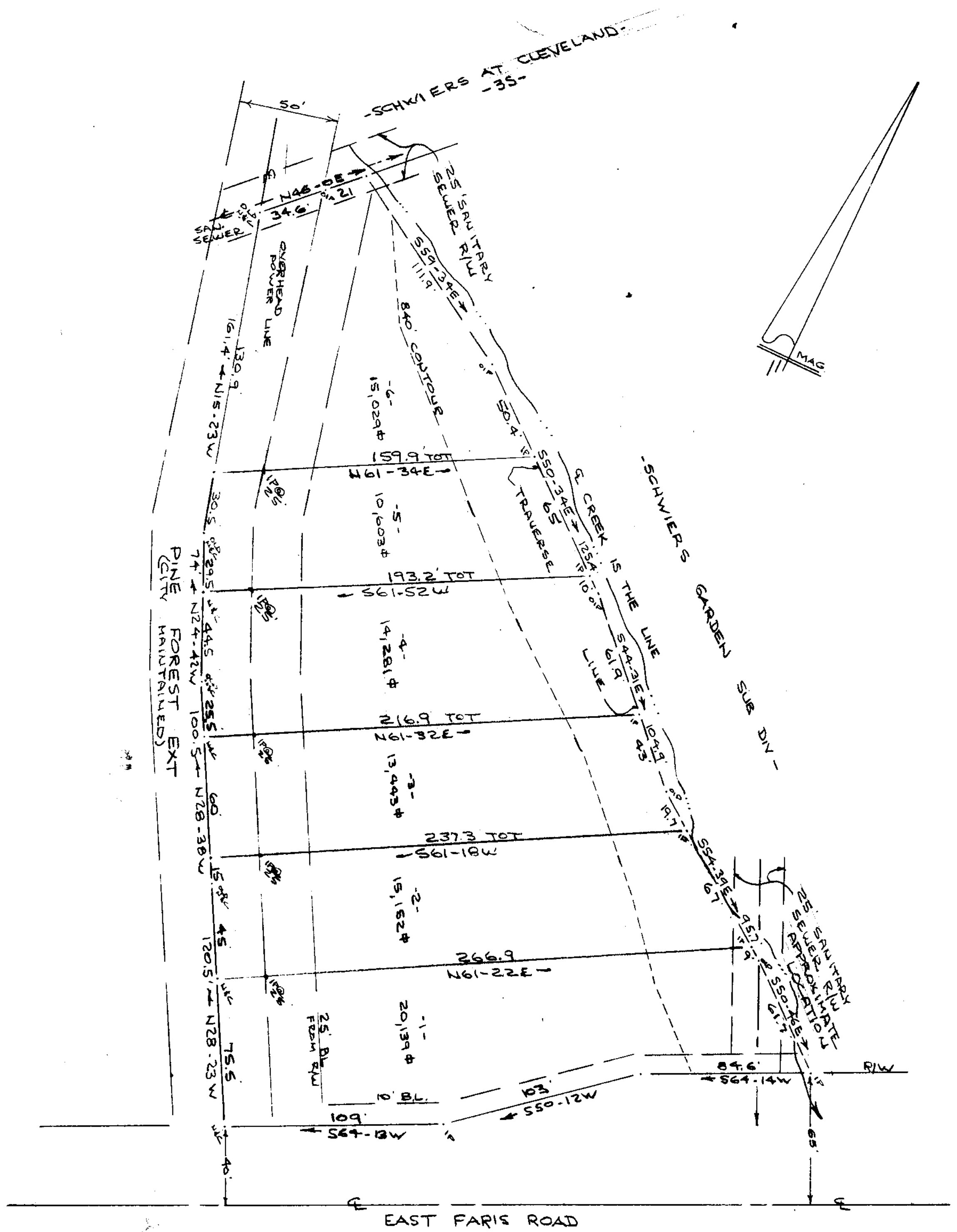

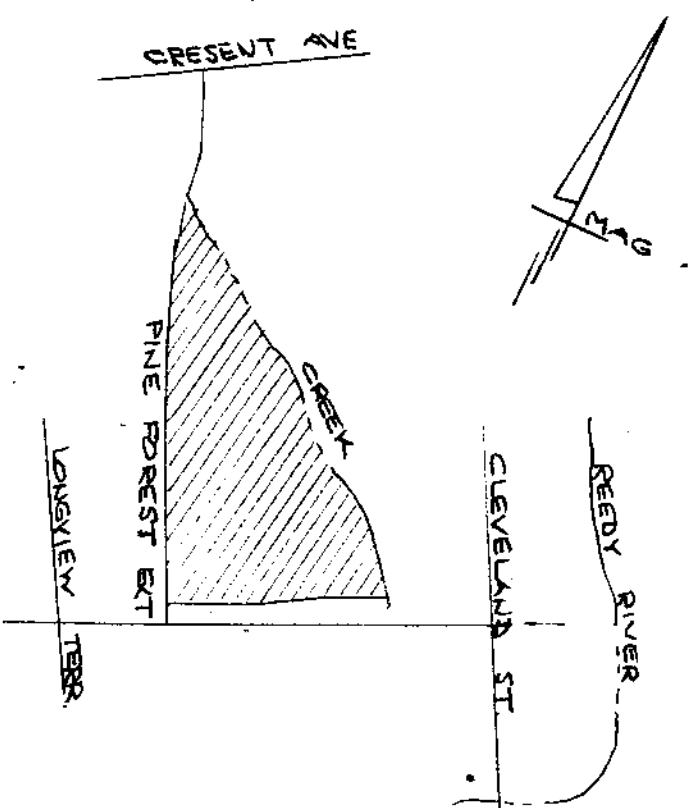
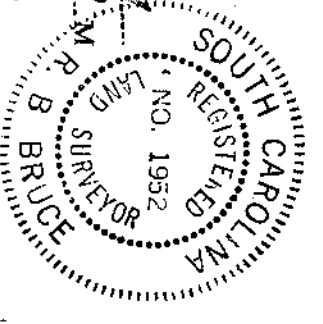


NOTE: 1. DRAINAGE & UTILITY EASEMENT ALONGS ALL SIDE & REAR LOT LINES.

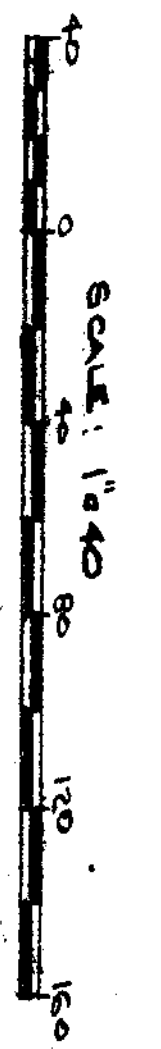
