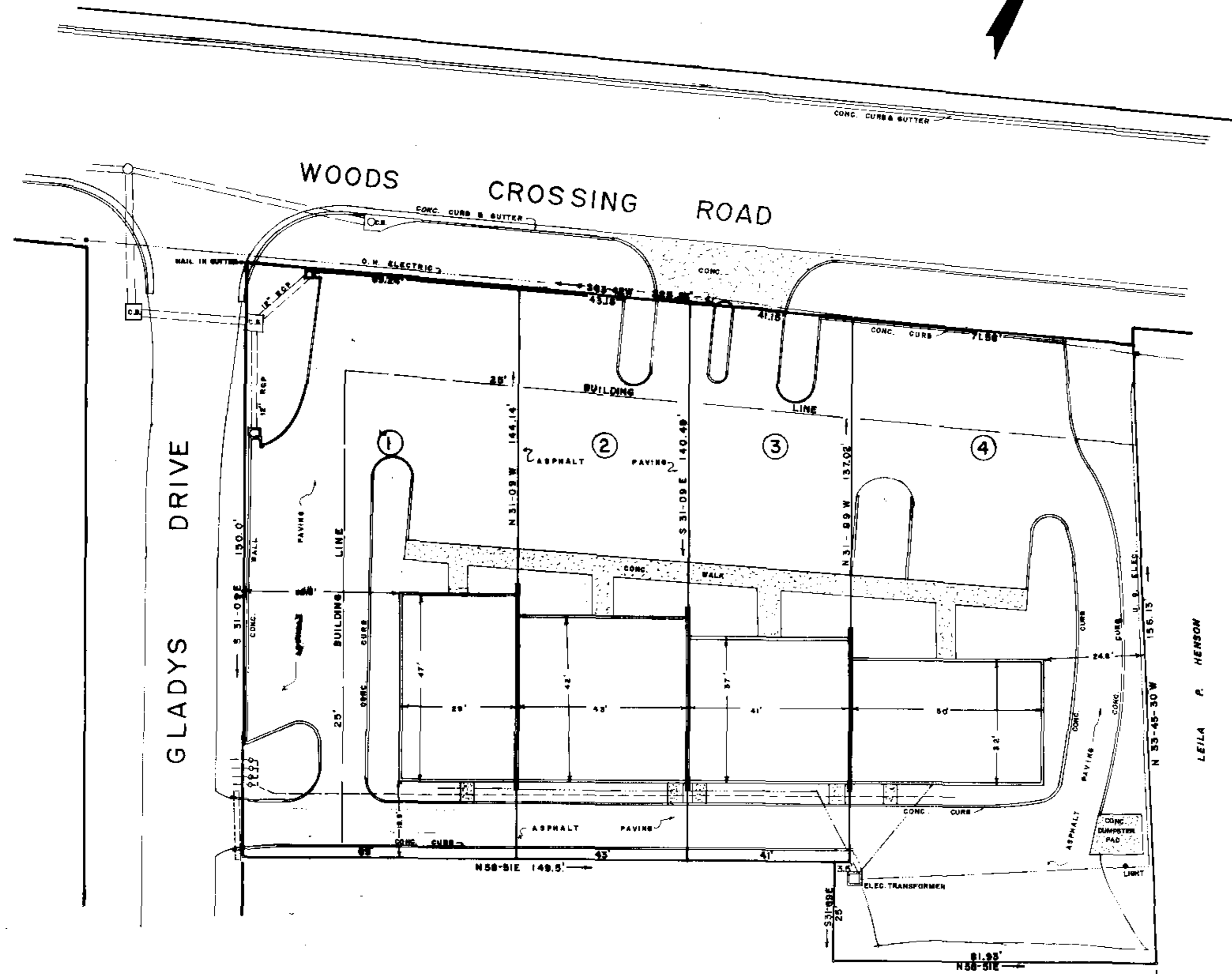


LOCATION MAP N/S
