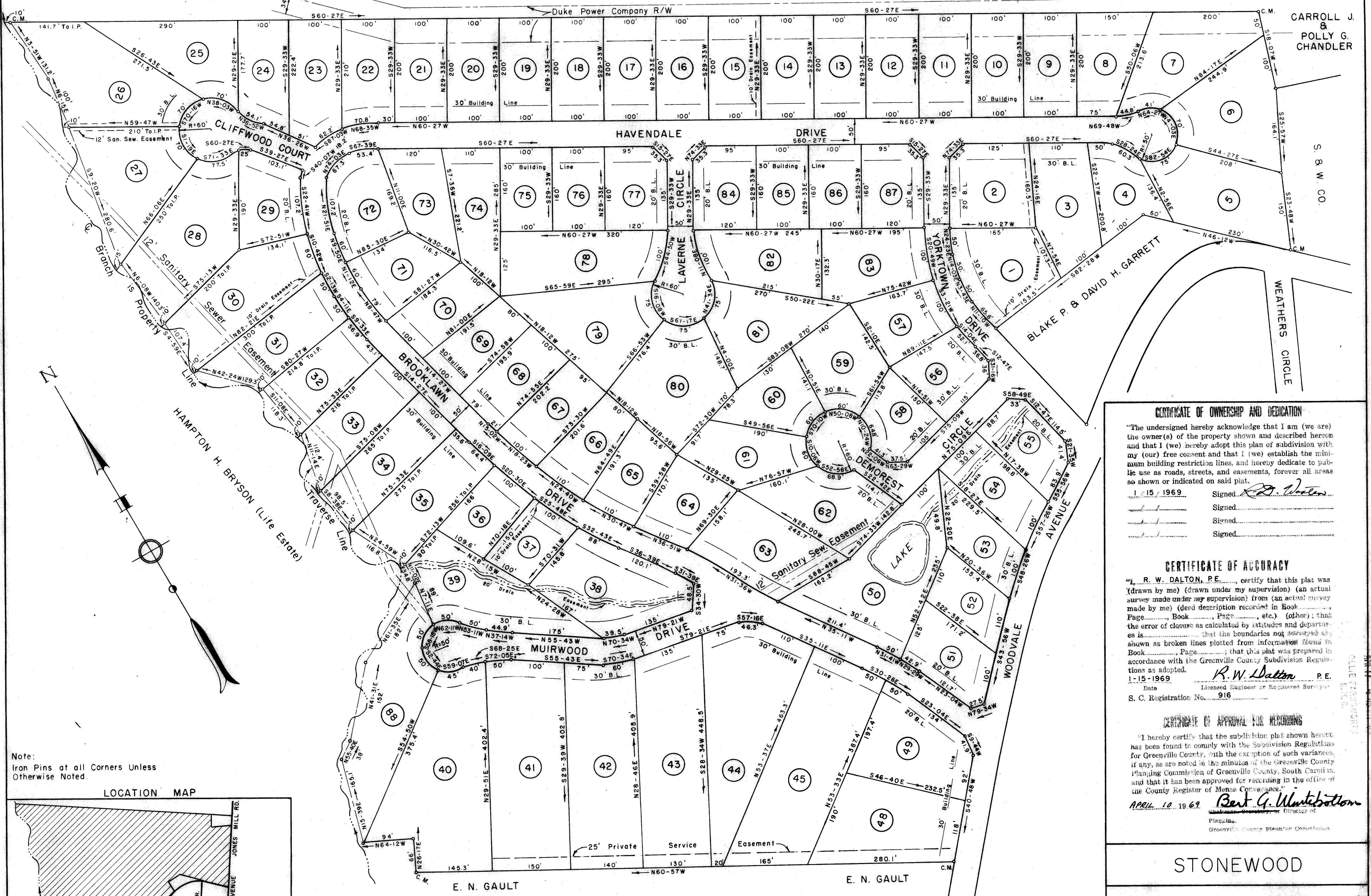

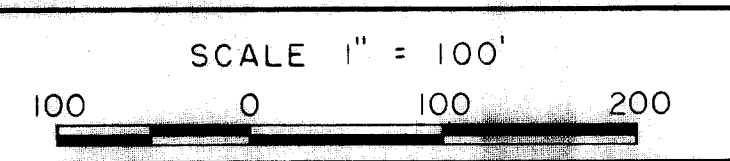

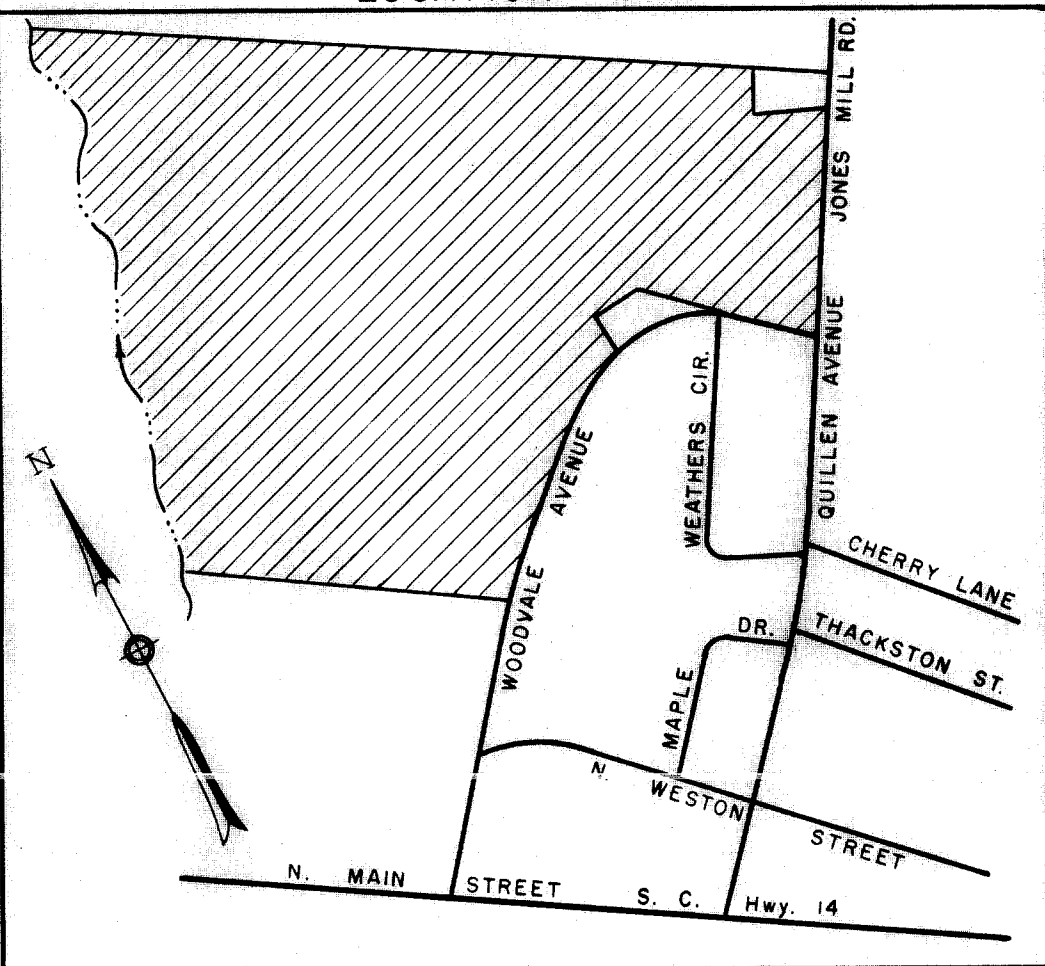


MAP OF
