WHEREAS, the Mortgagor is well and truly indebted unto Bank of Greer

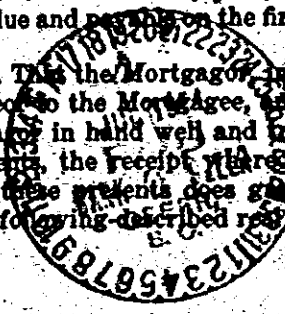
organized and existing under the laws of South Carolina, a corporation  
called the Mortgagee, as evidenced by a certain promissory note, of even date herewith, the terms of which  
are incorporated herein by reference, in the principal sum of Eighteen Hundred Dollars (\$ 1800.00 ), with interest from date at the rate of four and one-half per centum  
( 4 1/2 %) per annum until paid, said principal and interest being payable at the office of  
Bank of Greer in Greer, S. C.,  
or at such other place as the holder of the note may designate in writing, in monthly installments of  
Thirteen and 77/100 Dollars (\$ 13.77 ),  
commencing on the first day of August, 1949, and on the first day of each month thereafter  
after until the principal and interest are fully paid, except that the final payment of principal and interest  
if not sooner paid, shall be due and payable on the first day of July, 1964.

Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better  
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three  
Dollars (\$3) to the Mortgagor in hand well and truly paid to the Mortgagee at and before the sealing  
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,  
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its  
successors and assigns, the following described real estate situated in the County of Greenville,  
State of South Carolina:

All that piece, parcel or lot of land with the improvements thereon situate,  
lying and being in or near the City of Greer, Greenville County, South Carolina,  
and being more particularly described as Lot No. 20, as shown on a plat en-  
titled "A Subdivision for McCall Manufacturing Company, Greer, S. C.", made by  
Pickell & Pickell, Engineers, Greenville, S. C., May, 1949, and recorded in the  
R. M. C. Office for Greenville County in Plat Book S, at page 76. According to said  
plat the within described lot is also known as No. 201 Franklin  
Street (Avenue) and fronts thereon 76 feet.
