"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the town of Mauldin, on the south-eastern side of Knollwood Drive, and being known and designated as Lot No. 3 on a plat of Knollwood Heights, Section No. IV, recorded in the RMC Office for Greenville County, South Carolina, in plat book 4N page 74, and having according to said plat the following metes and bounds:

Beginning at a point on the southeastern edge of Knollwood Drive, at the joint front corner of Lots 3 and 4, and running thence along the line of lot 4, S. 13-57 E. 180.5 feet to a point; thence along a line of Lot 7, S. 72-41 W. 115 feet to a point on the northeastern edge of Kingsley Drive; thence along the northeastern edge of Kingsley Drive N. 15-30 W. 158.5 feet to a point; thence along the southeastern corner of the intersection of Kingsley Drive
