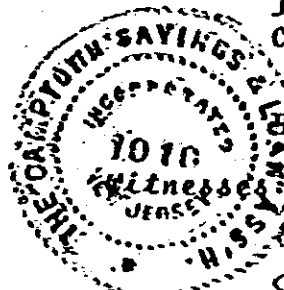
DENNIS L. JORDAN and BETTY S. JORDAN of
