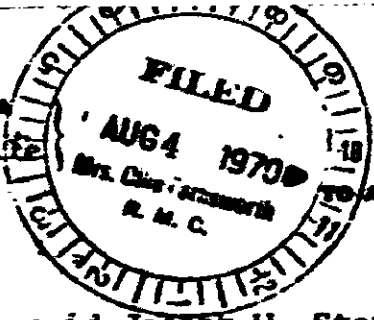

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagee in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns: Forever:

Beginning at a point on the West side of Bear Grass Drive at the joint front corner Lot #2 & #3, and running thence North 73-37, West 94.1 Ft., to a point thence North & 7-55, East 100 feet to a point on Folkstone Street, thence with said street, South 82-5, East 85 feet to a point on curve at Intersection of said Street and said Drivethence around curve of said Intersection, The Chord of which is so 33-12, East 39.2 feet to a point on said Drive, thence with said Drive south 15-41, West 100 feet to point of BEGINNING.
