with interest thereon from date *Oct 20 1974* at the rate of eight percent per annum, to be computed and paid monthly, as stated above, until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time not due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may thereon and foreclose this mortgage; and in case said note should be placed in the hands of an attorney for suit or collection the Mortgagor(s) agree(s) to pay all costs and expenses including a reasonable amount as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, on the southwestern side of Cardinal Drive, being shown and designated as lot number 8 on a plat prepared by Robert Jordan, R.L.S., dated April 6, 1967, entitled "Property of Lollie G. Gibson", and recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book 4D at page 199, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the southwestern side of Cardinal Drive at the joint front corner of lots numbers 8 and 9, running thence with the line of lot number 9 S. 70-23 W. 140.5 feet to an iron pin, thence S. 65-22 W. 20 feet to an iron pin; thence along the real line of lot number 90 S. 25-50 E. 73.3 feet to an iron pin joint rear corner lots numbers 8 and 8A as shown on the above mentioned plat; thence along with line of lot number 8A N. 70-23 E. 140.9 feet to an iron pin on the southwestern side of Cardinal Drive; thence with the southwestern side of Cardinal Drive N. 26-10 W. 75 feet to the point of beginning.
