NOW, KNOW ALL MEN, That the Mortgagors, in consideration of the aforesaid debt, and to have no security, now have, and do have other and further sums for which the Mortgagee may be indebted to the Mortgagors at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagee in hand cash and bills paid to the Mortgagee at and before the sealing and delivery of these presents, the mortgagee does hereby acknowledge, that the aforesaid debt and released and by these presents does grant, bargain, sell and release unto the Mortgagee his successors and assigns,

ALL the certain piece, parcel or lot of land with all improvements thereon, situate being in the State of South Carolina, County of Greenville, being known and designated as Lot #1, Monaview Subdivision, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book 4N at Page 52, and according to said plat having the following lines and bounds, to-wit:

BEGINNING at an iron pin on the northerly side of Rainbow Drive at the joint front corner of lots 1 and 2 and running thence with the joint line of said lots, N. 0-15 E., 143.1 feet to an iron pin; thence N. 87-38 W., 65 feet to an iron pin on the easterly side of Monaview Court and running thence with the easterly side of said Court, S. 4-10 W., 115 feet to an iron pin at the intersection of Monaview Court and Rainbow Drive; thence S. 37-38 E., 34.1 feet to an iron pin; thence S. 84-56 E., 60 feet to an iron pin, the point of beginning.
