"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

near the City of Greenville, on the Southwest side of Pemberton Drive, being shown as Lot No. 9 on Plat of Montroyal Hills recorded in Plat Book KK, at page 111, R.M.C. Office for Greenville County, and, according to said Plat, described as follows:

BEGINNING at an iron pin on the Southwest side of Pemberton Drive, front corner of Lot No. 10, and running thence with the line of said lot, S. 44-13 W. 256.4 feet to an iron pin; thence S. 40-09 E. 200 feet to an iron pin, rear corner of Lot No. 8; thence with the line of said lot, N. 32-15 E. 299.6 feet to an iron pin on the Southwest side of Pemberton Drive; thence with the Southwest side of said Drive, N. 55-03 W. 140 feet to the beginning corner.
