TO ALL WHOM THESE PRESENTS MAY CONCERN: Floree R. Croger

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, IN Ward 2, at the northwestern corner of Pettigru Street and Carolina Avenue, being shown and designated as Lot 6 on Block 10 on plat of Boyce Addition recorded in Plat Book A at page 179 and being more particularly described as follows:

BEGINNING at an iron pin at the northwestern corner of Pettigru Street and Carolina Avenue and running thence along Carolina Avenue, N 45 W 126.1 feet to pin on 10 foot alley; thence S 76-45 W along said alley for a distance of 76.8 feet to pin; thence with line of Lot 6, 126.1 feet to pin on Pettigru Street; thence N 76-45 E along Pettigru Street 76.8 feet to the beginning corner.
