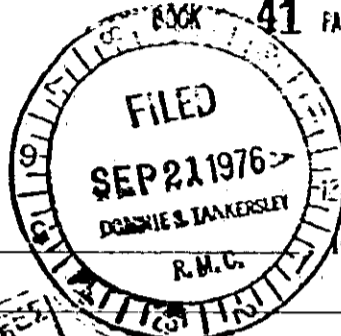

This mortgage, made this the 12th day of February 1973,

WHEREAS, the said Mortgagor is truly indebted unto AMERICAN CREDIT COMPANY OF

by these Presents do grant, bargain, sell and release unto the said Mortgagee, its successors or assigns, the following

described property situated in the County of Greenville, State of South Carolina:

All that certain piece, parcel or lot of land situate, lying and being on the northern
side of Parker Road approximately two miles from the Greenville County Courthouse
being known and designated as Lot 3 of the J. M. Clark property according to a plat
thereof by Dalton & Neves dated August 1930 recorded in the RMC Office for Greenville
County, South Carolina, in Plat Book H at page 175 and shown on a more recent survey
by Piedmont Engineering Service entitled "Property of Roy V. Capell" dated March 7,
1948, and having according to said plats the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint front corner of Lots 2 and 3 on the northern side
of Parker Road which iron pin is 446.5 feet from the corner of land now or formerly
