WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Butler Township, containing ten acres, located on the northern side of the Old Spartanburg-Greenville Road, and according to a plat made by H. S. Brockman, surveyor, on December 9, 1945, is described as follows:

"BEGINNING at a stake in the center of the Old Spartanburg-Greenville Road, at the corner of the property now or formerly belonging to Mrs. Elsie Hudson, and running thence with the line of said property, and with L. E. Hudson, N. 49-45 W. 864.3 feet to stone at the corner of property of E. G. Green; thence with the line of E. G. Green, N. 55-30 E. 620.5 feet to a point, corner of property of D. J. Brown; thence with the line of said property, S. 48-11 E. 400 feet to a stake; thence continuing along line of other property of D. J. Brown S. 19-48 E. 621 feet to a stake in center of County Road; at corner of property of Mrs. Bessie Garren and L. A. Cunningham; thence along the line of the Cunningham property, S. 87-00 W. 286 feet to a stake on the northern side of Old Spartanburg-Greenville Road; thence with the center of said road, S. 20-15 E. 25.5 feet and S. 71 W. 89.3 feet to the beginning corner."
