WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of -----
Two Thousand & NO/100----- DOLLARS

(\$2,000.00-----), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 6----- years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, about 5 miles from the Greenville Court House just off Paris Mountain Road and being shown on the county block Book as Lot 47, Block 1, Sheet P-31, and being more particularly described by metes and bounds, as follows:

BEGINNING at an iron pin at Pittman Road at the joint corner of the property now or formerly of Samny Keller and running thence with Pittman Road S. 89-30 E 162. feet to an iron pin; thence N. 46-15 E 196 feet to an iron pin at the joint corner of property now or formerly of Eld Davis and Sammons; thence with the north line N. 85-15 W 254 feet to an iron pin; thence N 18-20 E 162.6 feet to an iron pin at the point of beginning.
