G. Barry White and Susan V. White (hereinafter referred to as Mortgagor) SEND(S) GREETING

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-Two Thousand Nine Hundred Fifty and No/100ths

(\$ 22,950.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 25 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

ALL that certain piece, parcel or lot of land with the building and improvements thereon, situate, lying and being at the Southwest corner of the intersection of McPherson Lane (formerly referred to as McPherson Street) and McDaniel Court (formerly referred to as Carroll Street) in that area recently annexed to the City of Greenville, in Greenville, S. C. being shown as the greater portion of Lot 28 on Plat of T. Q. Donaldson Property made by Dalton & Neves, Engineers, April 1935, recorded in the RMC Office for Greenville County, South Carolina in Plat Book H, at Page 284 and having according to said Plat the following metes and bounds, to wit:

BEGINNING at an iron pin at the Southwest corner of the intersection of McPherson Lane and McDaniel Court, and running thence along the South side of McDaniel Court, N. 72-51 W. 171.6 feet to an iron pin; thence S. 11-29 W. approximately 91 feet to a point in line of Lot 27; thence with the line of Lot 27, S. 78-20 E. 170 feet, more or less to an iron pin on the West side of McPherson Lane; thence with the West side of McPherson Lane N. 11-29 E. 71.5 feet to the beginning corner.
