TO ALL WHOM THESE PRESENTS MAY CONCERN: That Creative Builders, Inc.

a South Carolina Corporation (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of
- - - - - Thirty thousand - - - - - DOLLARS

(\$ 30,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 29 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Frankfort, being shown and designated as Lot 16 on a Plat of Section 1, POWDERHORN, dated July 26, 1973, most recently revised March 1, 1974, prepared by Piedmont Engineers and Architects, recorded in the R.M.C. Office for Greenville County in Plat Book 4-X, at Page 95, and having, according to said Plat, the following metes and bounds:

BEGINNING at a point on the eastern side of Frankfort at the joint front corner of Lots 16 and 17 and running thence N 61-15 E, 149.90 feet to a point; thence proceeding N 31-30 W, 86.4 feet to a point at the joint rear corner of Lots 15 and 16; thence along joint line of said Lots, S 55-00 W, 150.00 feet to a point on the eastern side of Frankfort; thence along said Street, S 31-30 E, 70.0 feet to a point on eastern side of Frankfort, the point and place of Beginning.
