Harold E. Trammell and Dorothy S. Trammell

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Sixteen Thousand and no/100----

DOLLARS (\$ 16,000.00----), with interest thereon from date at the rate of Five & one-half per centum per annum, said principal and interest to be repaid in monthly instalments of One Hundred Ten & no/100--Dollars (\$ 110.00) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Eastern side of Stono Drive, in the City of Greenville, being shown and designated as Lot 8 of Section 3 of Stone Lake Heights, plat of which is recorded in Plat Book QQ at page 97, and according to said plat being more particularly described as follows:

BEGINNING at an iron pin on the Eastern side of Stono Drive, joint front corner of Lots 8 and 9, running thence with the line of Lot 9, S. 66-54 E. 183.9 feet to a pin; thence S. 17-21 W. 91.4 feet to a pin; thence continuing S. 31-02 W. 42 feet to a pin at rear corner of Lot 7; thence with the line of Lot 7, N. 66-10 W. 194 feet to a pin on Stono Drive; thence with the Eastern side of Stono Drive, N. 26-03 E. 130 feet to the Beginning corner.
